2010/2011 Tour Form – The Banff Mountain Film Festival Goes Global

During the 2010/2011 Tour, we will present films in about 30 countries, with a total audience of over 210,000 people. From armchair adventurers to world-class climbers, from business leaders to schoolchildren, from Argentina to Iceland and from South Africa to Japan – the World Tour is where you want your film to be. In addition to our well-established World Tour program, we also have a high-adrenaline, sport-oriented Radical Reels Tour based on our very successful Radical Reels festival night.

Each year, we select about 35 touring films from the festival entries. From these films, our local hosts work with us to assemble film programs that work best for their particular audiences.

OUTREACH – Your film can be seen by thousands of outdoor enthusiasts around the world.

CONNECTIONS – Many filmmakers have made valuable links for future projects from our screenings.

MONEY – We pay an annual royalty for screening your film.

Tour Selection

Film Length – Shorter films (5 to 15 minutes) are typically more popular than longer films on the Tour. If you are submitting a longer film to the festival, consider providing a shorter version (special edit or excerpt) for the Tour. Contact us for advice on this option.

APPROVAL – If you are interested in having your film on the Tour, please check “Yes” below. If we select your film, we’ll contact you with more details and an official contract. Note: all music licences must be obtained in order for your film to be considered for the Tour.

This form constitutes your expression of interest in the World Tour. It is not a binding agreement. If your film is selected for the Tour, a more detailed information kit, including contract and payment provisions, will be sent to you in the fall. The contract is a non-exclusive agreement for theatrical screenings only, so you are free to distribute, broadcast and present your film with other partners. Royalty payments are based primarily on the number of times a film is chosen by hosts for screening.

All entries to the Banff Mountain Film Festival are automatically listed in our catalogue of entries, our on-line database and the official festival program. In addition, filmmakers who agree to the uses below will have an opportunity to promote their entry globally to filmmakers, buyers, distributors, festival directors, researchers and the media by Banff Mountain Festival archive activities. **None of the uses listed below will take place without the express permission of the filmmaker.**
