Important Information Regarding The Banff Centre and its Research Ethics Policy:

The Banff Centre has developed a policy and procedures that guide interaction with human participants, based on the principle that our program participants must respect the dignity of human participants/subjects engaged in their projects. For projects deemed "research projects", it is mandatory to receive ethics review of the project. For projects deemed "creative projects", those who are engaged with human participants have two options. One option is to route the project through the Research Ethics Board on a voluntary basis. The second option is to sign the declaration (below) which attests that human participants will be treated with dignity and respect.
