

## Indigenous Leadership: Funding Form

### Funding Application

Through the generous support of our donors, Banff Centre for Arts and Creativity is pleased to offer a limited number of partial funding grants for Indigenous community members. Funding is allocated on a demonstration of need for funds, strength of an application and community eligibility so we encourage you to speak to the impact the program will have on you both personally and professionally

Your application for financial support will be reviewed and assessed on the basis of receiving the following information.

### Step 1:

#### Attach with your grant application a one page document outlining:

1. The reasons why assistance is required (e.g., limits in your organization's training budget, how many employees are covered by that amount, availability of training in your area, etc.).
2. The anticipated benefits you and your organization will derive from your participation in this program. Describe the impact this program will have on you both personally and professionally?
3. You/Your Organization's financial contribution to attendance of the program (i.e. how much are they able to cover towards the costs of tuition, accommodation and food).
4. Please specify any external grants you have or are applying to for additional support and the amounts.
5. The minimum amount of funding required from Banff Centre.

Tip: When calculating your numbers above please be aware that Banff Centre does NOT have funding available to cover the costs of travel. Therefore, all requests should be reflective only of the Program Costs as advertised in the fees and financial section of our program pages on our [website](#). There are external grants which you can apply to support your attendance, such as the [Canada-Alberta Job Grant](#) (provincial job grants and travel grants) along with the [Canada Council Travel Grant](#), which many of our participants successfully apply for.

### Step 2:

We require confirmation that you qualify for funding under the following criteria:

Indigenous or non-Indigenous Canadians who are employees or members of Indigenous nations, councils, enterprises, or institutions within Canada.

Please submit one of the following to meet this criterion:

- Letter from organization indicating you are a member or an employee of the organization
- Or Proof of Indigenous identity (e.g. Status Card, Metis membership, Inuit membership, band membership, etc.)

**Whilst your funding is under review we cannot guarantee the amount we can offer or availability of a place on the program.**

Once the funding review has been completed you will be notified if we have space on the program and sent an offer indicating the amount of funding we can support. You will then have time to review the offer and confirm if it meets your needs and are able to attend. Only on acceptance of the offer and payment of the deposit is your program confirmed. Many of our programs fill-up before the deadline we strongly recommend that you submit your grant request in full as soon as possible.

Please ensure your one-page funding application (Step 1) meets all of the above requirements and you submit your eligibility documentation (Step 2) and sign and return this form to [leadershipadmissions@banffcentre.ca](mailto:leadershipadmissions@banffcentre.ca) or fax 1 403 762 6345

#### Terms and Conditions

Once an amount of funding has been allocated to you, it is unavailable for someone else. For this, and additional reasons established by our donors, we have the following conditions attached to all of our grant awards.

1. The grant is awarded to the individual – payment is applied to their individual Banff Centre account.
2. The participant must complete the full course.
3. Should the intended participant not be able to attend, no substitutions are permitted.
4. Cancellations (less than two weeks prior to course start) and no-shows to the course selected may result in you being ineligible for further grants for at least one year. Regular cancellation penalties will also apply; please inquire for details.
5. Participants may be asked to meet with their donor at the Closing Banquet during the program to share their experience.
6. Participants receiving this funding must complete the required evaluation process at the end of the course.
7. Participants must provide donor thank-you letters and post-course requests for testimonials and additional feedback. Participants may also be asked to reflect on the expected benefits and processes, to share their learning, and report on the impact of the course on their leadership and organization.
